

# **Rocky Point Regatta**

## **NOTICE OF RACE**

Saturday September 17<sup>th</sup> & Sunday September 18<sup>th</sup> 2011  
Port Moody, Canada



### **1 Rules**

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Competitors shall wear life jackets or other adequate personal buoyancy at all times while on the water. Wet suits or dry suits are not deemed to comply with this requirement. This modifies the preamble to Part 4 and rule 40.1.

### **2 Advertising**

Advertising will be restricted to Category A.

### **3 Eligibility and Entry**

- 3.1 All Canadian competitors are reminded that they must be a member of a CYA member club and **MUST** be able to produce a CYA membership card. This is in accordance with ISAF regulations and will be enforced at the time of registration.
- 3.2 This regatta is open to the Laser, Laser Radial, Club420, Optimist.
- 3.3 Optimist competitors have been born in 1993 or later. A

### **4 Fees**

Registration Fees will be \$40.00 for all single-handed classes and \$60.00 for double-handed dinghy classes.

### **5 Provisional Schedule**

- 5.1 Registration will take place at RPSA Old Mill BoatHouse.
- 5.2 One race is required to constitute a regatta. If there are more than 5 races, the sailor's worst race will be discarded.
- 5.3 The scheduled time for the warning signal for the first race will be 11 00. Races following the first race of each day will start as soon as is practicable after the conclusion of the previous race.
- 5.4 Prize giving will be held on Sunday September 18<sup>th</sup>, 2011, as soon as possible after racing.

### **6 Courses**

- 6.1 The courses to be sailed will be published in the Sailing Instructions.
- 6.2 Course lengths will be such as to target sailing times of 20-30 minutes for Lasers, Laser Radials and Club 420s and 15-20 minutes for optimist.

### **7 Penalty System**

The Two-Turns penalty of rule 44.2 will be in effect, as will the provisions of Appendix P.

### **8 Scoring**

The Low Point System of Appendix A will apply.

### **9 Safety**

Competitors are reminded that this event occurs early in the season, and that cold temperatures and inclement weather are possible. Proper clothing that is suitable for such conditions should be worn. Competitors are referred to Rule 4, Decision to Race.

### **10 Disclaimer of Liability**

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
